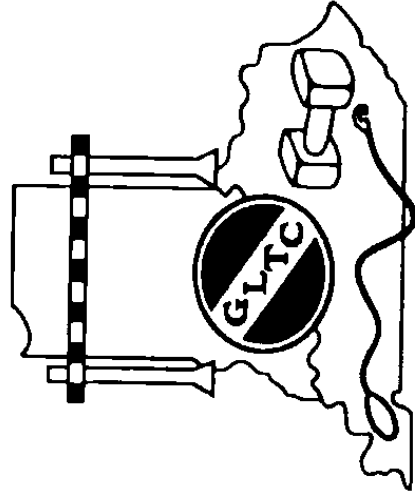

NOTICE TO EXHIBITORS

A RECORDING FEE of \$.50 will be required for each dog entered as well as an AKC Event Service charge of \$3.00. This is for each dog entered at any licensed or Member Club Show, Obedience Trial, or Tracking Test. This recording fee is to be collected by the show-giving club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the recording fee is to be collected on the first entry only (AKC Rule, Chapter 11, Section 2).

Entries received without fees will not be accepted.

UNSIGNED CHECKS AND RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by a judge or veterinarian, or barred from competition by the action of the Trial Committee.

Any exhibitor whose bitch has come in season after the closing date may obtain a refund of their entry, less \$10.00 for administration expenses, upon presentation of a Veterinarian's certificate to the Show Secretary prior to the start of any class the morning of the show.

No entry will be refunded if the Trial cannot be open or completed by reason of riots, civil disturbances, fire, an Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.

The show-giving Club assumes no responsibility for any loss, damages or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

The owner or handler of each dog is solely responsible for the presence of their dogs at ringside when it is judged. Judges are not obligated to wait for any dog.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. INSTRUCTIONS

Handlers may opt to enter in a higher height division for all *Regular* titling classes and the *FAST* titling classes, but not in a division lower than their proper height division.

Dogs entered in the *Preferred* classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. The Judge's measurement will be valid for this trial or *back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.
